

ORDINANCE 02-34

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

Re: No Parking Zones (Schedule M), Neighborhood Parking Zones (Chapter 15.37), and Restricted Turns at Signalized Intersections (Schedule H)

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.20.020 Schedule H shall be amended to add the following:

RESTRICTED TURNS ON RED AT SIGNALIZED INTERSECTIONS

Street	From	To
Seventh Street & College Avenue	West	South

SECTION II. Section 15.32.080 Schedule M shall be amended to delete the following:

NO PARKING ZONES

Street	From	To	Side of Street	Time of Restriction
Ninth Street	College Avenue	Walnut Street	North	Any Time
Weatherstone Lane	Woodlawn Ave.	800' E. of Woodlawn Ave.	North/South	Any Time

SECTION III. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES

Street	From	To	Side of Street	Time of Restriction
Ninth Street	College Avenue	Walnut Street	South	Any Time
Watson Street	Bryan Street	1 st Alley West of Bryan Street	North/South	Any Time
Weatherstone Lane	Woodlawn Ave.	800' E. of Woodlawn Ave.	South	Any Time


SECTION IV. Section 15.37.020 entitled "Applicability" shall be amended to add the following areas to Elm Heights University Proximate Residential Neighborhood Permit Parking Zone (Zone 1):

Street	From	To	Side of Street
Manor Road	Maxwell Lane	Sheridan Drive	East/West
Sheridan Drive	Woodlawn Avenue	Hawthorne Drive	North
Fess Avenue	Maxwell Lane	Northside of Bryan Park	East/West
Stull Avenue	Maxwell Lane	Northside of Bryan Park	East/West
Park Avenue	Maxwell Lane	Northside of Bryan Park	East/West

SECTION V. If any sections, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION VI. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.



SYNOPSIS

This ordinance makes several changes to the Bloomington Municipal Code. This includes restricted turns on red at signalized intersections, no parking zones and neighborhood permit parking zones.

Note: On November 13, 2002 the Council adopted Amendments 1 and 3, which affected Sections 2, 3 & 4 of the ordinance by expanding the Zone 1 of the Neighborhood Parking Program and by allowing parking on the north side of Weatherstone Lane.
