ORDINANCE 01-35

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED
"VEHICLES AND TRAFFIC"**

**(Recommendations from the Traffic Commission Regarding the Regulation of Certain
Intersections, Speed Zones, Parking Zones, and Cross Walks)**

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to delete the following:

STOP INTERSECTIONS

SECTION II. Section 15.12.010 Schedule A shall be amended to add the following:

STOP INTERSECTIONS

Traffic On	Shall Stop for Traffic On

SECTION III. Section 15.12.010 Schedule B shall be amended to add the following:

MULTI-STOP INTERSECTIONS

Fourth Street & Indiana Avenue	All-Way
Gates Drive, Jonathan Drive & Alexander Drive	4-Way
Gates Drive & Whitehall Crossing Blvd	All-Way

SECTION IV. Section 15.12.020 Schedule C shall be amended to add the following:

SECTION XI. Section 15.32.150 Schedule S shall be amended to add the following:

ACCESSIBLE PARKING FOR PERSONS WITH PHYSICAL DISABILITIES

100 Block of North College Avenue - one space mid-block between Kirkwood Avenue and Sixth Street, on the west side.

SECTION XII. Section 15.60.050 entitled "Pedestrians" shall be amended to add the following:

300 Block of North Drive between Walnut Street and Henderson Street

SECTION XIII. If any sections, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION XIV. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
