ORDINANCE 01-43

TO AMEND TITLE 2 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED  
"ADMINISTRATION AND PERSONNEL"

(Amending Chapter 2.21 "Department of Law" to Codify Anti-Discrimination Policy in  
Regard to the Provision and Implementation of City Programs and Services)

WHEREAS, it has long been the policy of the city that it does not discriminate in the provision or implementation of its programs and services on the basis of race, religion, color, sex, national origin, ancestry, sexual orientation, disability, number of dependents, marital status, age, pregnancy, or any other classification protected by city policy or applicable law; and

WHEREAS, there is value in making this policy more explicit and tangible by codifying it in the Bloomington Municipal Code;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 2.21.020 of the Bloomington Municipal Code shall be amended by adding the following sentence to the beginning of the first paragraph of that section:

It is the policy of the City that it does not discriminate in the provision or implementation of its programs and services on the basis of race, religion, color, sex, national origin, ancestry, sexual orientation, disability, number of dependents, marital status, age, pregnancy, or any other classification protected by city policy or applicable law.

SECTION 2. If any sections, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION 3. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
