

ORDINANCE 92-40  
TO AMEND THE 1992 SALARY ORDINANCE  
FOR APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. That from and after the date this ordinance becomes effective, the following classified position, salary and pay schedule be incorporated into Section I of Ordinance 91-39, fixing the salaries of appointed officers and employees of the City of Bloomington, Monroe County, Indiana:


SECTION IV. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.



#### SYNOPSIS

This ordinance amends the 1992 Salary Ordinance of appointed officers and employees of the City to add the position of Clerk/Typist in the Parking Enforcement Division of Public Works and amend Section II to include common law employees.

The Clerk/Typist position is being requested to provide additional clerical assistance with the new neighborhood parking program.

Section II is being amended to incorporate seasonal and temporary positions that were previously considered as independent contractual services and not subject to withholding exemptions. Due to a change in IRS regulations, these positions must now be classified as employees and income taxes withheld. This amendment will establish these positions within the city's pay structure.
