

ORDINANCE 87-21

To Vacate a Public Parcel  
Re: East and West alley running from Lincoln Street to Grant Street  
between Davis Street and East Grimes Lane (Free Methodist Church,  
Petitioner)

WHEREAS, IC 36-7-3-12 authorizes the Common Council to vacate public  
ways and places upon petition of persons who own or are interested  
in lots contiguous to those public ways and places; and

WHEREAS, the petitioner has filed a petition to vacate a parcel  
of City property more particularly described below:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE  
CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-3-12, a portion of  
City-owned property, to-wit the east and west alley running from  
Lincoln Street to Grant Street and lying between Davis Street and  
East Grimes Lane shall be vacated. The property is more particularly  
described as follows:

LEGAL DESCRIPTION FOR THE EAST/WEST ALLEY  
BETWEEN LOTS #18 & #19 AND LOTS #36 & #37  
IN THE CAPITAL PLACE ADDITION TO THE CITY  
OF BLOOMINGTON, MONROE COUNTY, INDIANA

Beginning at the Southeast corner of Lot #36 Capital Place Addition, thence  
south twelve feet to the Northeast corner of Lot #37 Capital Place Addition,  
thence west over and along the north line of Lot #37 to the Northwest corner  
of Lot #37, thence west twelve feet to the Northeast corner of Lot #18 Capital  
Place Addition, thence west over and along the north line of Lot #18 to the  
Northwest corner of Lot #18, thence north twelve feet to the Southwest corner  
of Lot #19 Capital Place Addition, thence east over and along the south line  
of Lot #19 to the Southeast corner of Lot #19, thence east twelve feet to the  
Southwest corner of Lot #36 Capital Place Addition, thence east over and along  
the south line of Lot #36 to the Southeast corner of Lot #36, said point being  
the point-of-beginning.

SECTION II. This ordinance shall be in full force and effect  
from and after its passage by the Common Council of the City of  
Bloomington and approval by the Mayor.
