

ORDINANCE 86-15

To Amend Title 15 of the Bloomington Municipal Code (Miscellaneous Traffic Changes)

WHEREAS, The Bloomington Traffic Commission has recommended certain changes in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

Section I. Section 15.12.010 "Stop Intersections" Schedule A shall be amended to delete the following entry:

<u>Traffic On</u>	<u>Shall Stop for Traffic on</u>
Second Street	Jordan Avenue

and Schedule B "Multi-Stop Intersections" shall be amended to add the following entry:

Second Street and Jordan Avenue 4-Way stop

Section II. Section 15.32.100 "Loading Zones" shall be amended to add the following entry:

311 South Lincoln, one space in front of Boys' Club

Section III. Section 15.32.080 "No parking zones", Schedule M shall be amended to add the following entry:

Fourth St.	Washington	Entrance to Municipal Parking Lot #3	North		anytime

and to delete the following entry from Schedule N "Limited Parking Zones":

Section IV. Section 15.32.110 "Bus zones" Schedule P shall be amended to add the following entry:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Fourth	Washington	Entrance to Municipal Lot #3	North


Section V. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section VI. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This Ordinance makes three changes in Title 15 of the Municipal Code entitled "Vehicles and Traffic", which were recommended by the Traffic Commission: Changes the intersection of 2nd and Jordan Streets from a 2-way to a 4-way stop; adds a loading zone in front of the Boys' Club at 311 South Lincoln; and prohibits parking on the north side of Fourth Street from Washington Street west to the entrance of the public parking lot, to allow bus loading zones at that location.
