

To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, ZO-32-84, and recommended that the petitioners, JOSEPH & THELMA CROUCH AND JON & GLORIA CHERKALA, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the zoning be changed from RH to BA for property located at 1430 Willis Drive, Bloomington, Indiana, more particularly described as follows:

151.4 feet of even width off the entire North side of the following described lands to-wit:

A part of the South half of Section 29, Township 9 North, Range 1 West in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point 1030.92 feet East and 268.0 feet North of the South half mile post of said Section 29; running thence North for a distance of 372.0 feet; running thence West for a distance of 124.35 feet; running thence South for a distance of 372.0 feet; running thence East for a distance of 124.35 feet and to the point of beginning, containing 1.06 acres, more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.


