

# MEETING SCHEDULE AND PROJECT DEADLINES

## Process

All persons seeking approval for a site plan, subdivision, rezoning, Planned Unit Development, or variance are encouraged to contact the City Planning and Transportation Department as early as possible to schedule a pre-application meeting. This meeting is required and must occur by the deadline listed in this schedule.

Following the pre-application meeting with Planning staff, the project will be scheduled for DRC review. Once an application has been filed, the deadline for submitting any revisions or additional information to staff is two weeks prior to the Plan Commission or BZA hearing, or as specifically noted in this schedule.

## The Development Review Committee

The Development Review Committee (DRC) was created to ensure a development review process that is fair, certain in timing, coordinated among reviewing departments, and thorough in its scope of review.
