The Development Review Committee (DRC) was created to ensure a development review process that is fair, certain in timing, coordinated among reviewing departments, and thorough in its scope of review.

Members

The DRC is made up of representatives of a variety of City of Bloomington departments and other local agencies.

Process

All persons seeking approval for a site plan, subdivision, rezoning, Planned Unit Development, or variance are encouraged to contact the City Planning Department as early as possible to schedule a pre-application meeting. This meeting is required and must occur by the deadline listed in this schedule.

Following the pre-application meeting with Planning staff, the project will be scheduled for DRC review. Once an application has been filed, the absolute deadline for submitting any revisions or additional information to staff is two weeks prior to the Plan Commission or BZA hearing, or as specifically noted in this schedule.

Schedule

Meetings of the DRC occur approximately every four weeks. All DRC meetings take place in the McCloskey Conference Room and begin at 1:30 pm, unless otherwise announced. Applicants are encouraged, but not required, to attend DRC meetings addressing their projects. All Plan Commission and BZA meetings take place in the City Council Chambers and begin at 5:30 pm unless otherwise announced.
