ORDINANCE 02-04

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

(Authorizing Traffic Calming Devices on Longview Avenue, Converting Southdowns and Sheridan Drives into a One-Way Pair, and Making Numerous Routine Changes in Traffic Regulations)

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:


SECTION XVII. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.





SYNOPSIS

This ordinance makes several changes to Title 15 of Bloomington Municipal Code. These changes authorize traffic-calming devices on Longview Avenue, convert Sheridan and Southdowns Drives into a one-way pair as part of a Greenways project, and make numerous other routine amendments to the code. These amendments affect stop intersections, multi-stop intersections, yield intersections, signalized intersections, one-way streets, restricted turns on red at signalized intersections, school, park and playground speed zones, no parking zones, limited parking zones and loading zones.

Motion to Divide the Question in Regard to Ordinance 02-04
(Amendments to Title 15)
For the March 20th and April 3rd 2002 Legislative Cycle
(Compilation of Memos and Record of Action on the Motion)

David has asked the Council Office to prepare the way for a Motion to Divide the Question on Ordinance 02-04. The objective is to divide the vote on this ordinance into three parts and allow a separate vote on each part. The motion would be stated as follows:

I move that the Council Divide the Question Regarding Ordinance 02-04 into the following three parts:

1. Longview Avenue and Glenwood Avenue West Traffic Calming Proposal;
2. Sheridan and Southdowns Drives Proposal; and
3. Remaining parts of the ordinance.

These three parts of the ordinance have been reduced to writing and distributed to council members.

If successful, this motion would require a vote on each of the above parts, but would not require a vote on the ordinance as a whole. If this motion were used at the Regular Session, then Regina would prepare minutes that reflect the votes in each of the three parts and note which parts had been adopted by the Council and which ones had not.

This motion applies to items with parts that can truly stand alone and are easily separable. It is in order after the main motion is introduced and all the way up to and including the call for the question. Since this is one piece of legislation, it will require a second, is undebatable, and needs a majority to succeed.

Note: I do not remember the Council ever dividing the question during my time here. It would be useful when: 1) there is legislation or a decision with parts that are independent of each other, and 2) there are members who support part of the list of proposals, but do not wish to be on record as supporting another part. Although you do not need to decide how the motion should be exercised in the future, I recommend the motion be considered a form of an amendment and, therefore, be reduced to writing before it is presented to the Council. This would avoid confusion about what was being considered and help assure the motion didn't inadvertently include what should have been excluded and exclude what should have been included. But, on the other hand, this would make the motion a little more difficult to invoke (less spontaneous) by not allowing members to make the motion without first thinking it through and submitting it to writing.
