

ORDINANCE 01-17

TO AMEND ORDINANCE 00-31  
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF  
THE CITY OF BLOOMINGTON FOR THE YEAR 2001  
Re: Positions in the Controller, Engineering and Street Departments

WHEREAS, the Job Evaluation Committee has reviewed the amended job description for the Budget & Research Manager position in the Controllers Office and has recommended a change in the grade; and

WHEREAS, the Engineering department wishes to add an Engineering Technician position to be funded by the Small Urban/Rural Planning Program through the Indiana Department of Transportation; and

WHEREAS, the Street department wishes to delete a Laborer I position and replace that job with a Laborer II position;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 00-31 shall be amended by changing the grade and pay maximum for the following positions, as indicated below:

SECTION 2. Section 1 of Ordinance 00-31 shall be amended by changing the number of employees for the following positions, as indicated below:



SYNOPSIS

This ordinance amends Ordinance 00-31, which fixed the salaries for officers and employees of the City for 2001. It follows the recommendation from the Job Evaluation Committee and raises the grade for the Budget & Research Manager in the Controller's Office. Additionally, the ordinance adds the position of Engineering Technician to the Engineering Department, funded by a grant from Small Urban/Rural Planning Program through the Indiana Department of Transportation. Finally, this ordinance replaces a Laborer I position in the Street Department with a Laborer II position.
