ORDINANCE 01-45

TO AMEND ORDINANCE 01-28

WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON FOR THE YEAR 2002

(Adding Grant-Funded Program Manager Position in the HAND Department)

WHEREAS, the Housing and Neighborhood Development Department wishes to add a Program Manager position to be funded with a grant from the federal office of Housing and Urban Development; and

WHEREAS, the new position was evaluated and assigned a Job Grade by the Job Evaluation Committee;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 01-28 shall be amended by adding another Program Manager position in the HAND department so that the entry for that department and job title shall read as follows:

SECTION 2. If any sections, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION 3. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
