ORDINANCE 89 - 55

To Amend the Bloomington Zoning Maps from RS to SI
RE: Property located at 1969 S. Henderson Street (SE corner of Miller Drive & Henderson St.)
(City of Bloomington Utilities Department)

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, ZO-66-89, and recommended that the petitioner, City of Bloomington Utilities Department, be granted an amendment to the Bloomington Zoning maps and request that the Common Council consider their petition for rezoning of certain property;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-4 that the zoning be changed from RS to SI for property located at the southeast corner of Miller Drive and Henderson Street and more particularly described as follows:


Lots 69, 70, and 71 of Barclay Gardens, Bloomington, Monroe County, Indiana.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.




