

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended that certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.24.020 Schedule I shall be amended to delete the following:

INCREASED OR DECREASED STATE SPEED LIMITS

Atwater Avenue	Dunn Street	Jordan Ave.	25 M.P.H.
Third Street	Dunn Street	Jordan Ave.	25 M.P.H.

SECTION II. Section 15.24.020 Schedule I shall be amended to add the following:

INCREASED OR DECREASED STATE SPEED LIMITS

Atwater Avenue	Dunn Street	High Street	25 M.P.H.
Third Street	Dunn Street	High Street	25 M.P.H.

SECTION III. Section 15.32.090 Schedule N shall be amended to delete the following:

LIMITED PARKING ZONES

Lincoln Street	1st Alley South of Third Street	Third St.	East	1 Hr.

SECTION IV. Section 15.32.090 Schedule N shall be amended to add the following:

LIMITED PARKING ZONES

Lincoln Street	1st Alley South of Third Street	Third Street	East	15 Min.


SECTION V. Section 15.32.100 Schedule 0 shall be amended to add the following:

LOADING ZONES


400 Block of Kirkwood, first space west of the north-south alley on the North side (between Grant and Dunn).


