

ORDINANCE 88-10

To Amend Title 15 of the Bloomington Municipal Code Entitled
"Vehicles and Traffic"

WHEREAS, The Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic":

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION IX. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

SYNOPSIS

This Ordinance makes several changes which the Traffic Commission has approved, some of which are to change various No Parking Zones and to change the length of time vehicles may park in the various pull-off spaces around town.
