

ORDINANCE 88-60

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED
"VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended that certain changes be made in Title 15 of the Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.16.020 Schedule F shall be amended to delete the following:

ONE WAY ALLEYS			
<u>Alley between</u>	<u>From</u>	<u>To</u>	<u>Direction of travel</u>
4th St. & 5th St.	Walnut St.	Morton St.	West
College Ave. & Walnut St.	Fifth St.	Fourth St.	South

SECTION II. Section 15.16.020 Schedule F shall be amended to add the following:

ONE WAY ALLEYS			
<u>Alley between</u>	<u>From</u>	<u>To</u>	<u>Direction of travel</u>
4th St. & 5th St.	College Ave.	Morton St.	West

SECTION III. Section 15.24.040 Schedule J shall be amended to delete the following:

PARK & PLAYGROUND SPEED ZONES			
<u>Street</u>	<u>From</u>	<u>To</u>	<u>Posted Speed</u>
Lincoln St.	Smith Ave.	Third St.	25 M.P.H.

SECTION IV. Section 15.24.040 Schedule J shall be amended to add the following:

SECTION VII. Section 15.32.100 Schedule O shall be amended to add the following:

LOADING ZONES

100 South College Ave, first space south of Kirkwood Avenue on the east side.

100 South Walnut from 190' to 130' South of Kirkwood Avenue on the west side.

SECTION VIII. Section 15.32.120 Schedule R shall be amended to add the following:

OFFICIAL VEHICLE ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
*College Ave.	4th space North of Seventh St.	5th space North of Seventh St.	West

*Marked Police vehicles only.

SECTION IX. Section 15.32.150 Schedule S shall be amended to add the following:

HANDICAPPED PARKING


Justice Building -- the first space North of Seventh Street on the west side of College Avenue.
