

TO AMEND CHAPTER 15.32 OF THE BLOOMINGTON MUNICIPAL CODE, ENTITLED "PARKING CONTROLS" AND TO ADD A NEW SECTION ENTITLED, "PARKING PROHIBITED FACING TRAFFIC"

WHEREAS, one provision in our previous Traffic Code made it a violation for drivers to park cars facing the flow of traffic and this section was inadvertently dropped from the Code in the recodification, and the Police Department recommends that it be included in the Code, and

WHEREAS, an additional No Parking Zone has been recommended by the Police Department,

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Chapter 15.32 of the Bloomington Municipal Code shall be amended to add a new section as follows:

15.32.180 Parking Prohibited Facing Traffic
 Except in those instances where angled parking is permitted in Schedule L, no person shall stand or park a vehicle on the street or roadway other than in the direction of lawful traffic movement, parallel to the curb and with the curbside wheels of the vehicle within 10 inches of the curb.

SECTION II. Section 15.32.180 entitled "Violations and Penalties" shall be renumbered Section 15.32.190.

SECTION III. Bloomington Municipal Code Title 15, Section 15.64.010 (d) Class D Traffic Violation (Mostly parking violations) shall be amended to include the following item:

15.32.180 Parking Facing Traffic.

SECTION IV. Section 15.32.080 No Parking Zone Schedule M shall be amended to delete the following items:

Third Street	Morton	Ist Alley East of Walnut St.	South	Anytime
Third Street	100' West of Morton St.	Walnut Street	North	Anytime

SECTION V. Section 15.32.080 No Parking Zone Schedule M shall be amended to add the following items:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of St.</u>	<u>Time</u>
Third Street	Rogers	Walnut	North	Anytime
Third	Jackson	Ist Alley East of Walnut St.	South	Anytime

SECTION VI Severability If any section of this ordinance or any part of any section shall be declared invalid or unconstitutional, such declaration shall not affect the validity or constitutionality of the remaining portions.

SECTION VII This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington, Monroe County, Indiana, and approval by the Mayor.

This ordinance amends Title 15 of the Bloomington Municipal Code to prohibit parallel parking of vehicles facing traffic flow and to require parallel parking vehicles' wheels to be within 10 inches of the curb and amends Schedule M of the Code to accurately reflect existing as well as additional No Parking restrictions on Third Street.
