

ORDINANCE 82-59

To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, PUD-22-82, and recommended that the petitioner, Southern Monroe Development Corporation, be granted an approval of a revised outline plan for the Planned Unit Development previously designated by Ordinance 80-5, and recommend that the Common Council consider their petition for approval of revised outline plans for certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC-18-7-4 and pursuant to Chapter 20.13 of the Bloomington Municipal Code, that a revised outline plan be approved for property located at 3633 Old Walnut Street Pike, further described as follows:

A part of the Southeast quarter of Section 16, Township 8 North, Range 1 West, in Monroe County, Indiana, bounded and described as follows, to wit: Beginning at a point on the West line of the said Southeast quarter, said point being 397 feet North of the Southwest corner of said quarter and in the centerline of South Walnut; thence North 0 degrees 53 minutes 40 seconds West along said West line and in the center of said road for 1125.74 feet, thence leaving said West line and road and running the following courses and distances: North 89 degrees 34 minutes 23 seconds East for 330 feet; thence North 0 degrees 53 minutes 40 seconds West for 165 feet; thence North 89 degrees 23 minutes 47 seconds East for 132 feet; thence North 0 degrees 53 minutes 40 seconds West for 445.50 feet; thence North 89 degrees 32 minutes 49 seconds East for 296 feet; thence North 0 degrees 53 minutes 40 seconds West for 38.75 feet; thence North 89 degrees 36 minutes 38 seconds East for 577.92 feet; thence South 0 degrees 22 minutes 07 seconds East for 1517.24 feet; thence West for 660 feet; thence South 0 degrees 26 minutes 40 seconds East for 263 feet; thence West for 660 feet and to the point of beginning; containing in all 43.49 acres, more or less, subject to a 25.00 foot right-of-way along South Walnut. EXCEPTING THEREFROM the following described real estate in Monroe County, Indiana, to wit: A part of the West half of the Southwest quarter of the Southeast quarter of Section 16, Township 8 North, Range 1 West, in Monroe County, Indiana, and more particularly described as follows, to wit: Beginning 396 feet North of a spike marking the Southwest corner at a PK Nail in the County Road; thence along the West line of said quarter and along said Road South 89 degrees 03 minutes East 660 feet to an iron pipe; thence South 132 feet to an iron pipe; thence North 89 degrees 03 minutes West 660 feet to the place of beginning; containing 2 acres, more or less.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.


