ORDINANCE 91-19

TO VACATE A PUBLIC PARCEL
RE: PORTION OF WEST SMITH AVENUE RUNNING BETWEEN MADISON AND
MORTON STREETS
(CFC, INC., PETITIONER)

WHEREAS, I.C. 36-7-3-12 authorizes the Common Council to vacate public ways and places upon petition of persons who own or are interested in lots contiguous to those public ways and places; and

WHEREAS, the petitioner, CFC, Inc., has filed a petition to vacate a parcel of City property more particularly described below; and

WHEREAS, in exchange for this vacation, the petitioner has agreed to dedicate a comparable right-of-way to the city more particularly described as follows:

Legal Description
(4 foot wedge area on the north side
of Smith Avenue as it exists)

Part of Seminary Lot Thirty-Two (32) in the City of Bloomington, Monroe County, Indiana, bounded and described as follows:
Beginning at a point on the north right-of-way line of Smith Avenue which point is 86.83 feet North 89 degrees 43 minutes 31 seconds East of and 16.50 feet North of the Northwest corner of Lot 4 in Howe's Addition to the City of Bloomington; thence North 78 degrees 24 minutes 56 seconds East, 20.39 feet; thence North 89 degrees 43 minutes 31 seconds East, 108.00 feet; thence South 78 degrees 57 minutes 53 seconds East, 20.39 feet; thence South 89 degrees 43 minutes 31 seconds West, 148.00 feet to the point of beginning, and containing 512 square feet more or less.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:


SECTION I. Through the authority of I.C. 36-7-3-12, a portion of City owned property shall be vacated. The property is an approximately 4 foot by 148 foot strip of ground more particularly described as follows:

Legal Description
(4 foot strip located within Smith Avenue as it exists)

Part of Smith Avenue right-of-way located between Lots 1,2,3 and 4 of Howe's Addition and Seminary Lot 32 in the City of Bloomington, Monroe County, Indiana bounded and described as follows: Beginning at a point which is 86.83 feet North 89 degrees 43 minutes 31 seconds East of the Northwest corner of Lot 4 in said Howe's Addition; thence North 78 degrees 25 minutes 34 seconds East, 20.41 feet; thence North 89 degrees 43 minutes 31 seconds East, 108.00 feet; thence South 68 degrees 03 minutes 10 seconds East, 8.01 feet; thence South 89 degrees 43 minutes 31 seconds West, 135.43 feet to the point of beginning and containing 430 square feet more or less.

SECTION II. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.




