

ORDINANCE 80-23

To Amend Section 2.02.040 of the Bloomington Municipal Code,
Concerning Residency Requirements for Appointments to Boards and Commissions


BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 2.02.040 of the Bloomington Municipal Code, entitled
"Appointments--Residential Requirement", shall be amended to read as follows:

2.02.040 Appointments--Residential requirement. All appointments to
city boards and commissions shall be made from residents of the city and its
two-mile fringe as defined by the city plan department, except those positions
on boards and commissions that are specifically required or allowed by state
law or city ordinance to be made from persons who are not residents of the
city and its two-mile fringe. In the event a member of a board or commission
no longer resides in the city and its two-mile fringe, the member shall imme-
diately resign and notify the appropriate appointing official or body.

SECTION II. This ordinance shall be in full force and effect from and
after its passage by the Common Council and approval by the Mayor.



SYNOPSIS

In 1976 the Council adopted a requirement that all appointments to city
boards and commissions be made from city residents except where exempted by
state or local law. A number of qualified applicants have been unable to
serve the city because they live beyond the city limits, but because these
boards and commissions often make policy that affects the two-mile fringe,
this ordinance has been submitted to amend the original requirement to allow
these persons to serve. The ordinance also clarifies that once a person
moves from the city and its two-mile fringe, he or she must resign from the
board or commission. The sponsor of the ordinance is Council President Allison.
