

ORDINANCE 80-59

To Amend the 1980 Civil City Salary Ordinance to Incorporate Two  
Omitted Positions in the Parks and Recreation Department

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF  
BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. From and after the first day of January, 1980, the following classified positions, pay rates and pay schedules for the Parks and Recreation Department be incorporated into Sections I and II of Ordinance 79-55, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:

Section 1. Parks and Recreation

Golf Attendant	4.45/hour



SECTION II. The rates shown as wages and salary for the positions listed above are the maximum rates for the referenced sections of the 1980 Salary Ordinance for Appointed Officers and Employees.




