

ORDINANCE NO. 80-77

AN ORDINANCE CONCERNING THE ANNEXATION OF
ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana,
is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the
same is, hereby annexed to and declared a part of the City of
Bloomington, Indiana, to-wit:

A part of the Northeast quarter of the Northwest
quarter of Section 16, Township 8 N, Range 1 West,
Monroe County, Indiana, described as follows; Be-
ginning at the Northwest quarter of said Section 16,
said point being on the centerline of Winslow Road;
thence East for 103 feet, and to the centerline
of State Road #37; thence on and along said center-
line of State Road #37 on a curve to the left having
a chord bearing of S 10°02'57"W and a distance of
321.27 feet; thence leaving said centerline and
running West for 42 feet; thence North 00°53'41"W
for 316.38 feet and to the point of beginning.
Containing in all 0.53 acres more or less. Subject
to a 30 foot right-of-way along the centerline of
State Road #37, also subject to a 25 foot right-of-
way along the centerline of Winslow Road. Containing
after said deductions 0.27 acres, more or less.


SECTION 2. Be it further ordained, that the boundaries of

and publication in accordance with the law.





The annexation as described, runs to the centerline of both abutting streets. S.R. 37 is in the City, so service responsibilities will not be affected. Winslow, however is not, and if this ordinance is adopted, we will assume jurisdiction of the south half of the r.o.w. It may involve repair responsibilities, as well as a rather modest additional plowing responsibility.

Otherwise, there will be no direct impact. Services to the area exist and it lies within our pattern of fire and police protection. The only costs will be the actual out-of-pocket cost of any calls experienced. Trash collection for the anticipated commercial use will be private.

Property tax revenues will be paid, but the City's total levy will not increase.
