

RESOLUTION 81-23

To Authorize the Filing of an Application for
a Grant Under Section 18 of the Urban Mass Transportation Act of 1964

WHEREAS, the U.S. Department of Transportation is authorized to make grants to states through the Federal Highway Administration (FHWA) to support capital and operating assistance projects for nonurbanized public transportation systems under Section 18 of the UMT Act of 1964, as amended; and

WHEREAS, the Division of Public Transportation, Indiana Department of Transportation (IDOT) has been designated by the Governor to make Section 18 grants for public transportation projects; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of projects costs; and

WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Urban Mass Transportation Act of 1964, as Amended, the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the Applicant that minority business enterprise be utilized to the fullest extent possible in connection with this project and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment contracts, or consultant and other services;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. The Mayor is authorized to execute and file an application on behalf of the City of Bloomington with the IDOT to aid in the financing of operating assistance projects pursuant to Section 18 of the Urban Mass Transportation Act of 1964, as amended.


SECTION II. The Mayor is authorized to execute and file with such applications an assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.

SECTION III. The Transit Director is authorized to furnish such additional information as IDOT may require in connection with the application or the project.


SECTION IV. The Transit Director is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.

SECTION V. The Mayor is authorized to execute grant contract agreements on behalf of the City of Bloomington with IDOT for aid in the financing of the operating or capital assistance project.


