TO TRANSFER APPROPRIATION WITHIN THE TRANSIT OPERATING FUND


SECTION I. The City Controller may adjust the appropriations of the following budget, to wit:

SYNOPSIS

The present Transit Department's budget was adopted prior to its moving into the new bus garage. The new facility requires unanticipated expenditures for utilities and additional funds are needed for repair of buses due to the expiration of warranties. Insurance premiums for Transit are less than anticipated for 1982, making funds available for a transfer.
