

ORDINANCE NO. 65-9

An Ordinance concerning the annexation of adjacent and contiguous territory pursuant to the filing of voluntary petition for annexation.

WHEREAS, the boundary of the City of Bloomington, Indiana, is along and adjacent to the real estate described herein, and

WHEREAS, the owners of a major part of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory, a major portion of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:


SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Southwest Quarter of the Northeast Quarter and a part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 8 North, Range 1 West, Monroe County, Indiana, more particularly described as follows: Beginning at a point on the now existing corporation line, said point being the intersection of the South line of Arden Place Addition with the West line of High Street; thence South on and along the West line of High Street to a point which is 165.00 feet North and 20.00 feet West of the Southwest corner of the Southwest Quarter of the Northeast Quarter of Section 10, Township 8 North, Range 1 West; thence North 90 degrees 00 minutes 00 seconds East for a distance of 349 feet; thence South 62 degrees 00 minutes 00 seconds East for a distance of 173.00 feet; thence South 09 degrees 00 minutes 00 seconds West for a distance of 91.31 feet and to the South line of said Southwest Quarter of the Northeast Quarter Section; thence South 89 degrees 12 minutes 54 seconds East on and along said South line of said Quarter Quarter Section for a distance of 851.78 feet and to the Southeast corner thereof; thence North 00 degrees 25 minutes 12 seconds West on and along the East line of said Quarter Quarter Section for a distance of 1325.64 feet and to the Northeast corner thereof; thence North 89 degrees 05 minutes 08 seconds West on and along the North line of said Quarter Quarter Section for a distance of 1289.62 feet and to the existing corporation line; thence following the existing corporation line to the point of beginning.

SECTION 2. BE IT FURTHER ORDAINED, that the boundaries of the City of Bloomington shall be, and the same, are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
