APPROPRIATION ORDINANCE 03-09

TO SPECIALLY APPROPRIATE FROM THE RISK MANAGEMENT FUND AND FROM THE CUMULATIVE CAPITAL IMPROVEMENTS (RATE) FUND EXPENDITURES NOT OTHERWISE APPROPRIATED

(Appropriating Monies For Worker's Compensation Expenses and for Insurance Premiums from the Risk Management Fund and Monies Received for Intersection Improvements at East Third Street and Clarizz Boulevard from the CCI (Rate) Fund)

WHEREAS, the City has determined the need to appropriate additional funds for casualty and liability insurance premiums; and

WHEREAS, the City has determined the need to appropriate additional funds for Worker's Compensation; and

WHEREAS, a sufficient balance remains in the Risk Management Fund to pay these expenses; and

WHEREAS, the city desires to make improvements to the intersection of East Third Street and Clarizz Boulevard; and

WHEREAS, the City has entered into three Plan Commission development agreements with property owners in the proximate area of the intersection whereby the property owners will partially fund the intersection improvements; and

WHEREAS, the City has received \$58,000 from the property owners which has been deposited into the Cumulative Capital Improvement (Rate) Fund and now desires to expend the funds according to the Plan Commission development agreements;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. For the expenses of said municipal corporation, the following additional sums of money are hereby appropriated and ordered set apart from the funds herein named and for the purposes herein specified, subject to the laws governing the same:


SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.




