

ORDINANCE 99-11

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC" (Including Routine Changes in Parking and Traffic Regulations, And Accompanied with Amendment 1)

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:



#### SYNOPSIS

This ordinance makes several changes to the Bloomington Municipal Code recommended by the Traffic Commission and City Engineer. These changes include stop intersections, yield intersections, signalized intersections, no parking zones, limited parking zones and loading zones. The ordinance, however, does not contain one change that was recommended by the Traffic Commission, but not supported by the City Engineer. After consultation with the Council Office, the Traffic Commission and City Engineer decided that whenever there was a disagreement on a particular recommendation, the disputed proposal would come forward as an amendment to the ordinance. In this case, the Traffic Commission requests that the Council consider Am 1, which accompanies this ordinance.

*Note: Amendment 1, which inserted a new Section XI and renumbered the existing section was adopted by the Council by a vote of 6 - 2.*

Section 15.20.020 Schedule H shall be amended to add the following:

RESTRICTED TURNS ON RED AT SIGNALIZED INTERSECTIONS

Intersection	From	To
High Street & Second Street	North	East

2. Renumber all subsequent sections accordingly.
