SYNOPSIS

This ordinance amends the 1998 salary ordinance for the Civil City (Ordinance 97-29) in regard to three departments. The amendments in the Planning and Information and Technology Services departments correct minor oversights in the grade and/or salaries of three positions, which will be funded out of those current budgets. The amendments in the Housing and Neighborhood Development Department address additional workload in the Neighborhood Development Division due to the increased number of rental units, time involved in addressing citizen complaints, as well as the time needed to plan and complete neighborhood programs. In order for that division to provide for the increase in services, the ordinance upgrades one position, downgrades another position, and adds another position. These staffing changes will be funded from the reorganization and from additional revenue generated by permit fee increases.
