RESOLUTION 98-20

APPROVING THE PURCHASE OF LAND FOR EXPANSION OF THE CASCADES GOLF COURSE (Hill Parcel)

WHEREAS,	the City of Bloomington Parks and Recreation Department ("Parks") operates the
	Cascades Golf Course, a public golf facility serving the Bloomington area; and

- WHEREAS, the 18-hole Cascades Golf Course is heavily used, and it is desirable to add an additional nine holes to the Cascades course to increase recreational opportunities for Bloomington-area residents; and
- WHEREAS, the Board of Park Commissioners approved its <u>Resolution 97-06</u>, in support of acquisition of two parcels of land adjoining the Cascades Golf Course that would be suitable for expansion of the course: a portion of the Hill property, consisting of approximately 40 acres ("Hill Parcel"), and a portion of the Lowdermilk property, consisting of approximately 20 acres ("Lowdermilk Parcel"); and
- WHEREAS, those two parcels are depicted on the attached maps, which are incorporated herein by reference, with two copies being available in the Office of City Clerk for public inspection; and
- WHEREAS, I.C. 36-1-10.5 requires the Common Council, as fiscal body of the City, to pass resolutions declaring their interest in purchasing these parcels; and
- WHEREAS, the Common Council passed <u>Resolution 97-10</u> which authorized the acquisition of the Lowdermilk Parcel in 1997, and acquisition is almost complete;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

- 1. The acquisition of the Hill Parcel for expansion of the Cascades Golf Course serves a public purpose and furthers the public welfare by increasing recreational opportunities in the Bloomington area.
- 2. The Bloomington Parks and Recreation Department is authorized to proceed with acquisition of the Hill Parcel subject to applicable Indiana law and the availability of funds for the purchase.
