

ORDINANCE 95-67

AN ORDINANCE CONCERNING THE ANNEXATION OF
ADJACENT AND CONTIGUOUS TERRITORY
(Third Street Crossing and Westplex)

WHEREAS, the boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land, commonly known as 1602 West 3rd Street and 135, 201, and 211 Westplex Avenue, be annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Southwest Quarter of the Southwest Quarter of Section 32, Township 9 North, Range 1 West, and a part of the Northwest Quarter of the Northwest Quarter of Section 5, Township 8 North, Range 1 West, Monroe County, Indiana, and being more particularly described as follows:


COMMENCING at the southwest corner of the Southwest Quarter of the Southwest Quarter of said Section 32; thence easterly 840 feet, more or less, along the south line of said quarter quarter section to the southwest corner of Annexation Ordinance Number 74-31 at the POINT OF BEGINNING; thence northerly 478 feet, more or less, along the west line of said Annexation Ordinance to the south line of Annexation Ordinance Number 85-62; thence along said Annexation Ordinance the following two (2) courses: 1). westerly 150 feet, more or less; thence 2). southerly 478 feet, more or less, to the aforesaid south line of the Southwest Quarter of the Southwest Quarter of Section 32; thence southerly 25 feet, more or less, to the south right-of-way of West Third Street; thence easterly 150 feet, more or less, along said right-of-way; thence northerly 25 feet, more or less, to the Point of Beginning, containing 2 acres, more or less.

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as part of the City of Bloomington, Indiana.


SECTION 3. Pursuant to I.C. 36-4-3-3(d), the above described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District 1.

SECTION 4. Pursuant to I.C. 36-4-3-7(d) this ordinance shall take effect sixty (60) days following its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor.
