## **ORDINANCE 94-62**

## AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY (Gentry Estates Area)

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION I. That the following described land, commonly known as the area between State Road 446, Smith Road, and East Third Street, including Gentry Estates phases I-IV, Janet Drive, the future site of Cedar Ridge on S. Parkridge Road, and Stonegate Drive, be annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of Section 1 and Section 2, Township 8 North, Range 1 West, Monroe County, Indiana, and being more particularly described as follows:

COMMENCING at the southeast corner of the West half of said Section 1; thence northerly 1023 feet, more or less, along the East line of said West half to the POINT OF BEGINNING; thence westerly 1284 feet, more or less, along the south line of Gentry Estates to the west line of the East half of said West half; thence northerly 2839 feet, more or less, along said west line to the south line of Baker Subdivision; thence westerly 1299 feet, more or less, along said south line to the west line of said Section 1; thence westerly 25 feet, more or less, to the west right-of-way of Smith Road; thence northerly 1194 feet, more or less, along said west right-of-way to the south right-of-way of East Third Street; thence easterly 25 feet, more or less, along said southerly right-of-way to the west line of said Section 1; thence easterly 225 feet, more or less, along said southerly right-of-way to the northwest corner of Annexation Ordinance Number 69-24; thence along said ordinance the following three (3) courses:

- 1). southerly 200 feet, more or less; thence
- 2). easterly 200 feet, more or less; thence
- 3). northerly 201 feet, more or less to the southerly right-of-way of East Third Street;

thence easterly 649 feet, more or less, along said southerly right-of-way to the northwest corner of Annexation Ordinance Number 92-60; thence along said ordinance the following two (2) courses:

- 1). southerly 200 feet, more or less; thence
- 2). easterly 858 feet, more or less, to the west line of Annexation Ordinance Number 73-30;

thence along said ordinance the following two (2) courses:

1). southerly 975 feet, more or less; thence

2). easterly 643 feet, more or less, to the east line of the aforesaid West half of Section 1;

thence easterly 60 feet, more or less, to the East right-of-way of State Road #446; thence southerly 2835 feet, more or less, along said east right-of-way to the extended south line of Gentry Estates; thence westerly 60 feet, more or less, along said extended south line to the Point of Beginning, containing 136 acres, more or less.

SECTION II. Be it further ordained, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as part of the City of Bloomington, Indiana.

SECTION III. Pursuant to I.C. 36-4-3-3(d), the above described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District Three.

SECTION IV. Pursuant to I.C.36-4-3-7(d) and (e) this Ordinance shall take effect the second January 1 that follows its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor, and the City herein acknowledges its obligations at the time of the annexation.
