ORDINANCE 93-18 TO AMEND TITLE 2 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "ADMINISTRATION AND PERSONNEL" (Rose Hill Fees)

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. <u>Section 2.11.060 Rose Hill Cemetery Department</u>, Subsection (3)(a)(3) is amended to delete "forty-five" and replace it with "seventy-five" where such appears in said subsection.

SECTION II. <u>Section 2.11.060 Rose Hill Cemetery Department</u>, Subsection (3)(c)(2) is amended to delete "forty-five" and replace it with "seventy-five" where such appears in said subsection.

SECTION III. <u>Section 2.11.060 Rose Hill Cemetery Department</u>, Subsection (3)(c)(4) is deleted and replaced with the following:

(4) The fee for interment of the remains of adults shall be two hundred forty dollars for interment on Mondays through Fridays, and two hundred seventy-five dollars for interment on Saturdays.

SECTION IV. <u>Section 2.11.060 Rose Hill Cemetery Department</u>, Subsection (3) (d) <u>Mausoleum Niches</u> is added as follows:

(d) The fee for the purchase of niches in the Mausoleum shall be \$1,200 per niche for the lower two rows of niches; \$1,500 per niche for the middle three rows of niches; and \$1,200 per niche for the upper five rows of niches.

SECTION V. This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor and promulgation by law.
