## ORDINANCE 93-53

## TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC" (Leased Spaces at Municipal Lot 3)

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. <u>Section 15.40.030 Parking permits</u>, subsection (a)(1) shall be amended to add the following sentence: "A limited number of annual parking leases, hereinafter referred to as Class A-3 permits (not to exceed 25% of the available spaces) for specific spaces in Lot 3 are available." This sentence shall be inserted after "A limited number of annual parking leases, hereinafter referred to as Class A-2 permits . . . for specific spaces in Lot 2 are available."

SECTION II. <u>Section 15.40.030 Parking permits</u>, subsection (a) shall be amended to insert "Lots 2, 3 and 5" in lieu of "Lots 2 and 5," and to insert "Class A-3" after "Class A-2" where such appears in said subsection.

SECTION III. This Ordinance shall be effective on January 1, 1994.

SECTION IV. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
