To Amend the Bloomington Zoning Maps from RS to RL,
Grant PUD Designation, and Outline Plan Approval
Re: 888 E. Hillside
(Terry Elkins)

SECTION I. Through the authority of IC 36-7-4 that the zoning be changed from RS to RL for property located at 888 E. Hillside. The property is further described as follows:

Barclay Gardens S 1/2 Lot 11 (Map No:015-36110-00), PT Lots 11 & 12 (Map No:015-54600-00), and S 1/2 Lot 12 (Map No:015-36120-00)

SECTION II. Through the authority of IC 36-7-4 and pursuant to Chapter 20.13 of the Bloomington Municipal Code, that an outline plan be approved and that the property described above be designated a planned unit development.

SECTION III. The Outline Plan shall be attached hereto and made a part thereof.

SECTION IV. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
