ORDINANCE 91 - 6

TO GRANT REVISED OUTLINE PLAN APPROVAL

555 South Smith Road (SE Corner of Smith Rd. & Third St.)
(Gwendolyn Baker Estate)

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, RS/PUD & BL/PCD-88-90, and recommended that the petitioner, the Gwendolyn Baker Estate, be granted approval of a revised outline plan and request that the Common Council consider their petition for approval of a revised outline plan on certain property;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 36-7-4 and pursuant to Chapter 20.13 of the Bloomington Municipal Code, that a revised outline plan be approved for the property located at the southeast corner of Third St. and Smith Road. The property is further described as follows:


A part of the North one half of the Northwest quarter of Section 1, Township 8 North, Range 1 West, Monroe County, Indiana, bounded and described as follows:

Beginning at the southwest corner of said northwest quarter; thence NORTH 0 degrees 05 minutes 56 seconds EAST (assumed bearing) 996.75 feet; thence SOUTH 88 degrees 40 minutes 23 seconds EAST 416.68 feet; thence NORTH 0 degrees 00 minutes 00 seconds EAST 200.00 feet; thence SOUTH 88 degrees 40 minutes 23 seconds EAST 1510.70 feet; thence SOUTH 0 degrees 00 minutes 00 seconds EAST 1174.78 feet; thence NORTH 89 degrees 19 minutes 36 seconds WEST 1929.16 feet to the point of beginning, containing 50.56 acres more or less.


SECTION II. The Revised Outline Plan, as approved by the Plan Commission, shall be attached hereto and made a part hereof.

SYNOPSIS

This request would amend the outline plan approved for the referenced property in 1984. The changes are summarized as follows: 1) Increase of the overall residential density in the PUD portion of the development plan from 6 units/acre to 7.1 units/acre; 2) Designation of 2.2 acres south of the former gas station at the corner of Third St. & Smith Road as BL/PCD with approved land uses of business and professional offices with accessory specialty stores and/or cafe not to exceed 3,000 sq. ft. per use; 3) Designation of previous business area at the southwest corner of the internal public streets as residential with density not to exceed 10 units/acre; 4) Elimination of the public street connection from the north/south collector street to the east property line; and 5) Straightening of the zoning line between the PCD and PUD sections of the property east of the north/south collector street.
