ORDINANCE 91-26

TO AMEND TITLE 15 OF THE BLOOMINGTON CODE ENTITLED  
"VEHICLES AND TRAFFIC"

WHEREAS, the Legal Department and the Traffic Commission have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic"

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Schedule A shall be amended to add the following:

STOP INTERSECTIONS

<u>Traffic On</u>	<u>Shall Stop For Traffic On</u>
Sunset Avenue	Park Square Drive
Park Square Drive	Belle Avenue
Belle Avenue	Park Square Drive

SECTION II. Section 15.12.010 Schedule A shall be amended to delete the following:

STOP INTERSECTIONS

<u>Traffic On</u>	<u>Shall Stop For Traffic On</u>
Park Square Drive	Sunset Avenue

Section III. Section 15.12.010 Schedule B shall be amended to delete the following:

MULTI-STOP INTERSECTIONS

Belle Avenue and Park Square Drive 3-way

Section IV. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Time of Restriction</u>
Seventh St.	205' East of Rogers	Morton St.	North	Anytime
Seventh St.	Union	Jefferson	Both	Anytime

Section V. Section 15.32.080 Schedule M shall be amended to delete the following:

NO PARKING ZONES

Seventh St. Union Jefferson South Anytime

Section VII. Section 15.32.090 Schedule N shall be amended to delete the following:

LIMITED PARKING ZONES

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>	<u>Time of Restriction</u>
Seventh St.	30' West Morton St.	126' West Morton St.	South	2 Hour (2)

SECTION VIII. Severability. If any section, sentence, or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provision, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Section IX. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.
