SYNOPSIS

These appropriations are needed for expenses not anticipated in the annual budget. Increases in the Personnel Department are the result of an error in the budget calculation of a part-time salary within the department. The increase in the City Clerk Department relates to additional pay for the Deputy Clerk during 1991.

The increase in Planning in other services will be used to partially fund the zoning update.

The transfer from Planning to Redevelopment will defray increased General Fund salary costs incurred by the Redevelopment Department for planning related work as well as increases in activities ineligible under the Community Development Block Grant such as Tax Abatement, Industrial Incentive Loans, Historic Preservation and Tax Increment Financing.

The increase in Fleet Maintenance is needed due to the promotion of an apprentice mechanic during 1991, as well as unanticipated increases in overtime usage.
