ORDINANCE 90-24

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE
ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Traffic Commission has recommended several changes in Title 15 of the
Bloomington Muncipal code entitled "Vehicles and Traffic";

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.12.010 Stop intersections shall be amended to add the following:

Chestnut Court	Highland Avenue
John Hinkle Place	Tenth Street

SECTION II. Section 15.24.020 Increased or decreased state speed limits shall be amended
to add the following:

SECTION III. Section 15.32.080 No parking zones shall be amended to add the following:

SECTION IV. Severability. If any section, sentence, or provision of this ordinance, or
the application thereof to any person or circumstances shall be declared invalid, such
invalidity shall not affect any of the other sections, sentences, provisions, or
applications of this ordinance which can be given effect without the invalid provision or
application, and to this end the provisions of this ordinance are declared to be
severable.

SECTION V. This Ordinance shall be in full force and effect from and after its passage by
the Common Council of the City of Bloomington and approval of the Mayor.
