RESOLUTION 90-35

TO AUTHORIZE LEASE OF OFFICE SPACE FOR THE DEPARTMENT OF HUMAN RESOURCES

- WHEREAS, the City of Bloomington commissioned a study by the Odle, McGuire & Shook Corporation (November 7, 1989) to determine the space needs of City administrative offices in one facility; and
- WHEREAS, the Odle study showed a need of 49,000 square feet for City offices where those offices currently comprise approximately 25,000 square feet; and
- WHEREAS, a comprehensive solution to the City's space needs problem is not imminent, and the crowded conditions at the Municipal Building need abatement; and
- WHEREAS, the Department of Human Resources has a dire need for handicapped-accessible office space to serve the needs of its client base; and
- WHEREAS, under the Odle study the Department of Human Resources shows a need for over 2000 square feet of office space and common space to enable its continued efficiency in the daily operation of the department; and
- WHEREAS, the City administration has researched several possible lease locations in the downtown and recommends leasing 2047 square feet of office space at One City Centre for a two (2) year term with options to renew as the most prudent and effective means of housing the offices of the Department of Human Resources; and
- WHEREAS, the space at One City Centre is available for \$18,887 in 1991 and for \$20,876 in 1992, inclusive of heating, cooling, ventilating, electricity and common area maintenance; and
- WHEREAS, One City Centre is accessible to all people; and
- WHEREAS, relocating the Department of Human Resources to One City Centre will help to relieve the cramped conditions in the Municipal Building while the City continues to consider options for a new city hall; and
- WHEREAS, in accordance with Indiana Code 36-1-10-7 the Board of Public Works has accepted the requisite Petition Requesting Lease of Office Space which is signed by more than fifty (50) owners of taxable real estate located within the corporate boundaries of the City of Bloomington;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA THAT:

The Common Council of the City of Bloomington hereby finds that the lease of additional office space is needed, and approves and authorizes the lease of space at One City Centre in Bloomington for the public purpose of alleviating the crowded conditions at the Municipal Building. Said lease shall provide for 2047 square feet of handicapped-accessible office space for the Department of Human Resources. The lease term shall be for two (2) years and may be renewed subject to funds being budgeted for said public purpose.
