## <u>To Amend Title 9 of the</u> <u>Bloomington Municipal Code, Entitled "Water"</u>

## BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 9.08.010 <u>Monthly rates generally</u> of Chapter 9.08 of title 9 of the Bloomington Municipal Code, shall be amended to read as follows:

<u>9.08.010 Monthly rates generally.</u> The following rates and charges are established for the use of and service rendered by the water utility of the city. Each customer will pay a monthly charge according to the following schedules:
