Specifically, it adds three signalized intersections, a school zone, a no parking zone, a limited parking zone and a change in the state speed limit. The request for angle parking did not receive Traffic Commission approval. The ordinance also deletes multi-stop intersections where the signalized intersections are to be acided.
