SYNOPSIS

Additional appropriations needed in four funds, as follows:

Local Road & Street

The S124,250 request represents the local share (25%) of construction costs for the Third Street reconstruction project. Total construction costs are estimated at \$665,330, including signal modernization at \$168,300 (100% federally funded). In addition \$88,330 is requested for construction engineering, of which \$64,922 (75%) will be reimbursed with federal funds. The project includes widening Third Street to two lanes of traffic in each direction with reconstructed curbs and sidewalks and a separate left turn lane, new traffic signals and other intersection improvements.

An additional \$30,000 is needed to extend Highland Avenue from Thorton Drive to Hillside Avenue. The northern section is being constructed by the developer of Cedar Ridge subdivision, with the remainder being funded jointly by Local Road & Street and Community Development Block Grant Funds.

Cumulative Capital Development

Improvements to the Fourth & Washington parking lot were included in the capital improvements plan for 1988. However, to coordinate the improvements with the downtown bus terminal project, it is proposed that implementation be accelerated. Improvements include redesign and layout of the lot, new surface, striping and bumper blocks.

Parking Meters

Additional funds are needed for the operation of the Fourth & Walnut parking garage. This request provides for attended parking 75 hours per week, plus an additional 180 hours for the part-time clerk typist to accelerate collections on violations.

Additional funds are also needed to cover electric utility costs at the new garage.

General/Personnel

Funds are needed for completion of a comprehensive position classification plan. The last evaluation was done in 1976. The rassage of time and numerous adjustments have rendered the present system functionally obsolete.
