ORDINANCE 86-3

To Amend Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic"

- WHEREAS, The Traffic Commission has recommended certain changes be made in Title 15 of the Bloomington Municipal Code Entitled "Vehicles and Traffic";
- NOW, THEREFORE, BE IT HEREBY ORDAINED By the Common Council of the City of Bloomington, Monroe County, Indiana:

Section I. Section 15.32.030 Schedule L shall be amended to read, for the first Seventh Street entry, as follows:

ANGLE PARKING

Seventh Street First Alley West Morton North of College Avenue Street

Section II. Section 15.32.080 Schedule M shall be amended to read, for the second Faculty Avenue entry, as follows:

NO PARKING ZONES

Street From To Side of Street Limit

Faculty Avenue Hunter Avenue Atwater East Anytime Avenue

Section III. Section 15.32.080 Schedule M shall be amended to add the following:

NO PARKING ZONES

Street ' From To Side of Street Limit

Franklin Road Third Street N. Corporation North/ Anytime Line South

Section IV. Section 15.32.100 Schedule O shall be amended to add the following:

LOADING ZONES

- 100 Block of West Fourth Street, first space east of College Avenue on the south side.
- 100 Block North College, between Kirkwood Avenue and Sixth Street, one space in front of the alley closed to vehicular traffic located between 109 and 113 North College, on west side.
- Section V. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circum-

stance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section VII. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
