

RESOLUTION 86-17

A RESOLUTION REGARDING THE CREATION OF THE
BLOOMINGTON AND MONROE COUNTY BOARD OF PARK COMMISSIONERS

WHEREAS, the Common Council has adopted Ordinance 86-20, thus adopting I.C. 36-10-4, et seq., and creating the four member Bloomington and Monroe County Board of Park Commissioners; and

WHEREAS, the Bloomington and Monroe County Board of Park Commissioners must act quickly in order to take action upon the pressing issues which it faces; and

WHEREAS, the Bloomington Common Council wishes to endorse the eventual extension of the park district's boundaries to include all of Monroe County, and to provide further guidance to the Bloomington and Monroe County Board of Park Commissioners.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON THAT:

Section 1. The declaration made by the Mayor that an emergency exists, necessitating immediate appointment of the four members to the Bloomington and Monroe County Board of Park Commissioners is hereby affirmed.

Section 2. The Bloomington Common Council hereby recommends that one of the Mayor's four appointments to the Bloomington and Monroe County Board of Park Commissioners, as provided for by Section 2.20.010 of the Bloomington Municipal Code, be made with the advice of the Monroe County Community School Board, from a member of said School Board.

Section 3. The Bloomington and Monroe County Board of Park Commissioners is hereby encouraged to meet and cooperate with the Monroe County Parks Board, in order to continue the good working relationship between the City and County parks boards.

Section 4. The Bloomington and Monroe County Board of Park Commissioners is hereby encouraged to adopt a resolution extending the boundaries of the park district to include the boundaries of Monroe County.

Section 5. Upon successful extension of the park district boundaries to include Monroe County, and prior to January 1, 1987, the Common Council shall adopt an ordinance creating a five member Bloomington and Monroe County Board of Park Commissioners.

Section 6. Upon the creation of the five member Bloomington and Monroe County Board of Park Commissioners, the Common Council hereby recommends that one of the Mayor's appointments to that five member Board be made upon the recommendation of the Monroe County and Richland-Bean Blossom School Corporations, from a member of one of the respective school boards. In addition, the Common Council hereby recommends that the Mayor seek the recommendation and advice of the Monroe County Commissioners concerning the Mayor's appointment of a school board member to the Board of Park Commissioners.

Section 7. The Bloomington and Monroe County Board of Park Commissioners is hereby encouraged to adopt a resolution requesting the Bloomington Common Council to adopt an ordinance establishing a cumulative building fund, as provided for by I.C. 36-10-4-36,

which will provide for an annual tax levy intended to pay for land to be acquired for any of the purposes permitted by statute and/or an improvement authorized by statute, not to exceed ten cents on each one hundred dollars of taxable personal and real property in the district.


Section 8. Severability. If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.





SYNOPSIS

This Resolution recommends (1) immediate appointment of the members of the Bloomington and Monroe County Board of Park Commissioners; (2) that one of the Mayor's four appointments to the Bloomington and Monroe County Board of Park Commissioners be made from a member of the Monroe County School Board; (3) that the newly formed Bloomington and Monroe County Board of Park Commissioners continue to meet with the Monroe County Parks Board; (4) that the Bloomington and Monroe County Board of Park Commissioners adopt a resolution extending the park district boundaries to the boundaries of Monroe County; (5) that prior to January 1, 1987, the Common Council adopt a resolution creating a five member Bloomington and Monroe County Board of Park Commissioners; (6) that one of the Mayor's appointments to the five member Bloomington and Monroe County Board of Park Commissioners be made from the membership of the Monroe County or Richland-Bean Blossom School Boards, with the advice of the Monroe County Commissioners; and (7) that the Bloomington and Monroe County Board of Park Commissioners adopt a resolution requesting the Common Council to adopt an ordinance establishing a cumulative building fund.

JOINT RESOLUTION OF THE

have endorsed the creation of the Bloomington and Monroe
County Board of Park Commissioners.


NOW, THEREFORE, BE IT RESOLVED BY THE BLOOMINGTON AND MONROE COUNTY
