SYNOPSIS

This ordinance amends the 1985 Salary Ordinance, Fixing the Salaries of Utilities Employees. The construction of the Solids Handling Facility was recently completed and is now ready for on line use, which creates the need for a Solids Handling Specialist.

SOLIDS HANDLING SPECIALIST

<u>GENERAL STATEMENT OF DUTIES:</u> Oversees the operations of the solids disposal operations. Does related work as required.

DISTINGUISHING FEATURES OF THE CLASS: The employee in this class is responsible for proper operation of digesters, sludge lagoons and dredge, sludge drying beds, grit removal, centrifuges, rotatory screens, and related equipment. Supervision is exercised over mechanical equipment operator III.

EXAMPLES OF WORK: (Illustrative Only)
Trains seasonal and temporary employees;
Trains shift operators on the proper operation of the centrifuges;
Hauls or pumps dewatered or thickened sludge to lagoons or drying beds;
Keeps equipment clean;
Operates centrifuges, dredges, and other equipment when needed;
Keeps areas clean such as, sludge areas, haul roads, drying beds,
centrifuge building, polymer building;
Schedule with supervisors a preventative maintenance program and down time
of equipment;
Performs chemical evaluations on dewatering chemicals;
Performs biological and chemical testing on digesting sludges and dewatered
sludge;
Complete daily, monthly, and yearly reports.

<u>REQUIRED KNOWLEDGE, SKILLS AND ABILITIES:</u> Thorough knowledge of modern wastewater treatment plant principles and operating practices; ability to plan and supervise the work of others; ability to keep accurate records and make concise reports; good judgment; good physical condition.

ACCEPTABLE EXPERIENCE AND TRAINING: Considerable experience in wastewater treatment plant operations. Completion of standard high school course, pre-ferably supplemented with chemistry or related subjects; or any equivalent combination of experience and training which provides the required knowledge, skills and abilities.

ADDITIONAL REQUIREMENTS: Possession of a Class II Wastewater Treatment Operator's Certificate by the State Board of Health is desirable.
