## ORDINANCE 83-66

## To Amend the Bloomington Zoning Maps, Dated June 7, 1978

WHEREAS, the Common Council passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 7, 1978 which are now incorporated in Title 20 of the Bloomington Municipal Code; and

WHEREAS, the Plan Commission has considered this case, ZO-75-83, and recommended that the petitioner, CFC, INC, be granted an amendment to the Bloomington zoning maps and request that the Common Council consider their petition for rezoning of certain property:

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the zoning be changed from BG to RH for property located at 211 East 6th Street and 210 North Washington Street, and more particularly described as follows:

In Lot Number 234 in the City of Bloomington, Indiana, as shown by the recorded plat thereof.

ALSO, the South half of In Lot Number 233 in the City of Bloomington, Indiana, as shown by the recorded plat thereof.

ALSO, all that part of Washington Street in said City which lies East of Washington Street as the same is now improved and which lies opposite and abutting the South half of said In Lot Number 233 in said City, all of which real estate is more particularly described as follows, to-wit: Beginning at the Southeast corner of said In Lot Number 233 and running thence West on the South line of said In Lot, 80 feet, more or less, to the East line of said cement side walk as now constructed and located along the East side of said Washington Street in said City; thence North along and with the East line of said cement side walk 66 feet; thence East parallel with the South line of said In Lot to the East line of said In Lot 233; thence South along and on said East line of said In Lot 233, 66 feet, more or less, to the place of beginning.

ALSO, the North half of In Lot Number 233 in the City of Bloomington, Indiana, as shown by the recorded plat thereof.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and Approval by the Mayor.
