#### RESOLUTION 83-42

To Confirm Resolution 83-41 Which Designated the Adjacent Properties Located at 211 East Sixth Street and 210 North Washington Street as an "Economic Revitalization Area"

- WHEREAS, CFC, Inc. has filed an application for designation of the adjacent properties located at 211 East Sixth Street and 210 North Washington Street, (the old Monroe County Courthouse Annex Building property and the Headley Building property), as an Economic Revitalization Area; and
- WHEREAS, the Application has been reviewed by the Departments of Redevelopment and Planning, and the Redevelopment Commission has passed a Resolution approving the designation and recommending to the Common Council the approval of the Economic Revitalization Area designation for said adjacent properties; and,
- WHEREAS, the Common Council has investigated the properties described in detail in Exhibit "A", attached hereto and made a part hereof, more commonly described as 211 East Sixth Street and 210 North Washington Street; and,
- WHEREAS, the area described above has become undesirable for normal development and occupancy due to the deterioration of improvements, age, obsolescence, and substandard building conditions; and,
- WHEREAS, This Common Council did pass Resolution 83-41 on December 7, 1983, which designated the above property as an Economic Revitalization Area, and did cause to be published a notice of the passage of Resolution 83-41, and did request in such notice that persons having objections or remonstrances to the designation appear before the Common Council at its regular public meeting on December 21, 1983;
- WHEREAS, The Common Council has reviewed and heard all such objections and remonstrances to such designation.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

1. The Common Coucil affirms its determination made in Resolution 83-41, that the area described above and in Exhibit "A" is an Economic Revitalization Area, as set forth in Indiana Code Code 6-1.1-12.1-1 et. seq.

### SYNOPSIS

CFC, Inc. has filed an Application for designation of the adjacent properties located at 211 East Sixth Street and 210 North Washington Street (the old Monroe County Courthouse Annex Building property and the Headley Building property) as an Economic Revitalization Area. Indiana law provides that upon a finding by the Common Council that an area is an Economic Revitalization Area, property taxes are reduced on improvements to that real estate for a ten year period. Property tax rates and assessments on land and improvements existing prior to the designation are not reduced.
