ORDINANCE 81-44

To Amend the 1981 Salary Ordinance for Appointed Officers and Employees to Create the Position of Animal Control Officer

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. From and after the nineteenth day of March, 1981, pursuant to IC 18-2-1-10, the following classified position, salary, and pay schedule for the Animal Control Department be deleted from Sections I and II of Ordinance 80-63, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:

SECTION III. The rate shown as wages and salary for the position listed above is the maximum rate.
