To Amend the Bloomington Zoning Maps, Dated June 7, 1978

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Through the authority of IC 18-7-4 that the zoning be changed from <u>BL(limited business) to BG (general business)</u> for property located at <u>1100 West 11th Street</u> more particularly described as:

> Lot #6 in J.N. Alexander's Addition to the City of Bloomington, Indiana, as shown by the plat thereof, recorded in Plat Book #1, page 24, in the office of the Recorder of Monroe County, Indiana.

SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
