

ORDINANCE 80-12

To Amend Section 9.08.070, "Late Payment Charge", and To Repeal Chapter 9.12, "Water Service Charges", of the Bloomington Municipal Code

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 9.08.070 of the Bloomington Municipal Code, entitled "Late Payment Charge" shall be amended to read as follows:

9.08.070 Late Payment Charge. Except as otherwise provided, all bills shall be due and payable monthly and bills unpaid more than twenty-five days following the date of mailing shall be considered delinquent. Delinquent bills shall include a late payment charge of 3% of the unpaid bill.

SECTION II. Chapter 9.12 of the Bloomington Municipal Code, entitled "Water Service Charges", shall be repealed.

SYNOPSIS

IC 8-1-2-100 provides that utilities service boards fix the policy of control over municipal utilities, including the establishment of rates and other regulations, with the approval of the municipal council. In May, 1979, an ordinance establishing general rules, water rates, and water service charges for the city water utility was adopted, but because the water service charges will be revised annually to reflect inflationary increases and because they involve more internal affairs than do water rates, the Utilities Director has suggested that the Council not enact a new ordinance each time these rates are increased. This ordinance, an alternative to Ordinance 80-11, would repeal the sections in the Code on water service charges to reflect this change and would revise a section on late payment charges as suggested by the Public Service Commission.
